AOS: Epistemology, philosophy of mind and language, history of analytic philosophy.

AOC: Critical thinking, metaphysics.

Short description

In epistemology, I have developed a form of "hinge epistemology" and I have explored its bearing on skepticism, relativism, knowledge of basic logical laws and other basic principles of human inquiry. I am now working on its extension to themes in social and applied epistemology (disagreement, testimony, trust, epistemic injustice).

At the interface between epistemology and the philosophy of mind, I have developed a pluralistic account of self-knowledge – that is, our knowledge of our own mental states. I have investigated its consequences with respect to self-deception, Moore's paradox, intrapersonal disagreement and belief revision.

In philosophy of mind and language, I have worked on indexicals, particularly 'I', and demonstratives, on the nature of perceptual content and on the nature of concepts and of intentional mental states.

In history of analytic philosophy, my work concerns mostly G. E. Moore and L. Wittgenstein. I have focused on their writings in epistemology and on the philosophy of mind and language of the "later" Wittgenstein. More recently, I have developed an interest in the work of Susan Stebbing (a philosopher of common sense and the first woman philosophy professor in the UK), as well as in Wittgenstein's morphological method and Goethe's influence on him and other members of the Vienna Circle, such as Friedrich Waismann.

I am also interested in the dissemination of knowledge in the digital era, and in medical epistemology.
